RULES FOR BOYS HOSTEL

1. The hostel accommodation will be given to the students on the merit basis and as per beds allocated department-wise by the Institute Authority.
2. **Submission of address and Phone Number of Local Guardian is mandatory for all the Hostlers for emergency purposes.**
3. **The Parents are advised to answer the Phone Calls of the Warden or any other Institute official even at odd hours.**
4. **The outing timings for boys from Monday to Friday are 05:00 PM to 08:00 PM and for Saturday and Sunday are 09:00 AM to 08:00 PM.**
5. **The outing timings for girls from Monday to Friday are 05:00 PM to 07:00 PM and for Saturday and Sunday are 09:00 AM to 07:00 PM.**
6. **Institute authorities can cancel or withdrawn Outings at any point of time.**
7. **The students who are allotted accommodation in the hostel will have to continue for full session.**
8. **The Institute will provide sharing accommodation with cots, chairs and tables to the hostellers. However, the bedding, linen, tumbler, thermos, bucket, etc. will be brought by the student. The students will be responsible for the up keep of the Institute property and the articles issued for use in the hostel, any type of damage to the property/articles, the cost will be recovered from the students. Hostel students should not write anything on the walls, doors or windows or cause any damage to the Institute property. Shouting/demonstration is prohibited.**
9. **The hostlers are not allowed to keep any valuable articles such as jewelry, heavy cash, expensive electrical/electronic gadgets etc. in their rooms. The Institute under no circumstances will be responsible for the loss of any valuable articles, however Any hostellers found to be violating of the above rules will be liable for disciplinary action.**
10. **Consumption of alcoholic drinks, smoking, drugs and gambling are prohibited. Bottles other than plastic are not allowed to be kept in the room. Objectionable materials (magazines/cassettes/CDs/Weapons etc.) are not allowed to be kept in the hostel room. If found under the influence of Alcohol or any other objectionable substance or NDPS item strict disciplinary action will be taken and the hostel facility will be withdrawn with immediate effect.**
11. **The dining in the Mess is compulsory for all the students residing in the Hostel Accommodation. The other rules of dining in the Mess and timings will be intimated by the Mess In-charge separately.**
12. **Food from the mess or from outside is not allowed to be taken in the Hostel Rooms it should be consumed only in Hostel Mess. Hostellers are directed not to order food from any online food delivery apps still if they have to order the food the timings should be between 05:00 PM to 08:00 PM and enter the details of the order with Date and Time in the Register with the security.**
13. All hostellers should carry their identity cards issued by the Institute, even while going out or to the mess during free times the students are not permitted to wander in the other parts of the Institute building.

- 14. No electrical appliances are permitted to be used in the rooms, in case of default the students will be liable for fine or disciplinary action as decided by the Institute Authority.**
15. The hostellers will submit the form/undertaking in duplicate duly filled in all respect alongwith photographs, specimen signatures of the visitors who will be authorized to meet the hostellers by their parents or guardians. No person other than the authorized ones will be allowed to meet the hostellers.
- 16. Non hostellers and guests are not allowed to visit/stay in the hostel. In case any outsiders/day scholars are found visiting/sitting in anyone's room they will be liable for fines or disciplinary action as decided by the Principal.**
- 17. Students are required to instruct their friends and relatives not to call them on the office telephone during working hours unless in case of emergency.**
- 18. The students are required to keep their rooms locked while going outside. The students are further required to be economical as far as possible in using the water and electricity and keep their rooms clean and tidy all the times. The hostellers are not allowed to use any type of heater/stove/electrical gadget/meddle with the fittings in their rooms.**
- 19. Ragging is not permitted, anyone found indulging in such activities will be liable for severe disciplinary action as per the law.**
20. The hostellers are not allowed to keep any type of vehicle in the Institute. In case any body wants to keep/use the vehicles they will have to take the prior permission from the Principal for the same.
21. The hostellers must leave the Hostel at 8.45 AM on working days to attend the classes.
22. Any change in the rules and regulations will be intimated from time to time.
23. Permission to go home would be granted by the warden only after she/he gets the consent of the parents over the phone.
24. Permission for the weekend outings to be taken from the warden on the last working day of the week (Friday) in the college itself. No student to approach the warden at her/his residence for the grant of permission on weekends.
- 25. Doctor is available in the Institute for a period of 01 Hour everyday however in case of any ill health the student would be taken immediately to the nearest hospital but the expenses of the medicine incase of any treatment have to be borne by the student himself/herself.**
26. Each hosteller is required to perform specific duties in the mess on rotation basis as per the directives of the mess in charge.
27. Hostellers are required to switch off the lights and fans when not in use as power backups will remain active only for four hours. While leaving the hostel on the completion of the term, hostellers are required to handover their room to the Maintenance Incharge and obtain No Dues Certificate. The amount of any damages will be recovered from hostel caution money.
28. For the allotment of the room in the hostel, decision of the warden will be final and binding for all the hostlers.

29. The hostel management reserves the right to make spot/surprise checks without having to give prior notice to the students.
30. Hostellers are advised to lock all doors at all times for security reasons.
31. Hostellers are not permitted to change rooms or sleep anywhere other than in their own room.
- 32. Hostellers are not permitted to undertake any part-time job or join part time courses unless with approval of Hostel Warden. However they will have to perform operational duties in Hotel Chandigarh Beckons and other Special Duties as and when directed by the authority.**
33. No Student will be allowed to leave the Hostel without the telephone call arrival from Parents/Local Guardian from the Mobile no given in the Hostel form.
- 34. Hostel has to be vacated within 24 Hours of Finishing of the Final Examination.**
